**Comply Quality & Standardization Certificates Issuing Services (CQC)** does not offer an internal audit service to its certified clients.

**Comply Quality & Standardization Certificates Issuing Services (CQC)** does not own or have any interest in any other company that offers certification or management system consultancy services.

**Comply Quality & Standardization Certificates Issuing Services (CQC)** does not have any relationships with companies who offer consultancy or other services that can be interpreted as having an impact on the certification services provided by CQC.

Any proposed relationship between **Comply Quality & Standardization Certificates Issuing Services (CQC)** and any other company will undergo a risk assessment by the Committee for Impartiality prior to that relationship being formalized.

Any current relationships with companies, organizations and individuals will be risk assessed on a regular basis to ensure that the relationship does not impact upon the impartiality of the certification process.

Exceptionally and at the discretion of the Technical Manager or Directors an individual or sub-contractor may be allocated to a management system audit where a past relationship has existed but there has been no relationship for a minimum of 2 years.

**Comply Quality & Standardization Certificates Issuing Services (CQC)** will not offer any commission, to any individual or company.

Auditors and others involved in the certification process are not and will not be put under any pressure and will not be influenced in any way to come to a particular conclusion regarding the result of an audit.
